Narrative Compilation

What were your primary takeaways from this workshop (things that were most impactful or that you most remember)?

- I enjoyed the varied perspectives and looking at this subject from different angles.
- John's devotional on presence and promise. The myths attached to risk. No one
 way to handle risk in any given situation. Each situation has to be taken on its
 own merit.
- The many accounts in Acts of risk and suffering; the passage in 2 Cor. 11 that lists decades of experience with danger. Paul's emphasis on what to expect is very, very clear.
- Risk is taken for the glory of God, for the sake of the gospel and by the leading of the Holy Spirit. We are to consider our motivations when taking risks.
- The spiritual growth that can come through suffering if we keep close to Jesus every step of the way.
- If God allows hardship into our lives as believers, then he's also committed to walk through it with us.
- That biblically there are several reasons why people suffer and we cannot know for sure which one(s) is the cause.
- It was so, so good to be able to share with a variety of people of different generations and experiences to remind me that I'm not the only one who deals with these issues!

Please give an example of how this workshop has shaped your thinking or behavior.

- It encouraged me that others are thinking about this subject and that it is worth the time to study.
- In dealing with people who may face suffering and risk, I was encouraged to be more bold with Scripture as encouragement and help.
- For several years I have been working out a theology of suffering. The theology
 of risk is important to the work of CURE as we offer spiritual and physical healing

- in difficult places of the world and as we interact with cultural attitudes towards disability.
- It has increased my awareness that we are also to show mercy and grace to each other and ourselves when taking or not taking risks.
- I have an inner peace while facing an unknown future that will no doubt include suffering.
- I appreciated going through the scriptures ahead of time and then walking through Acts there and seeing the different ways risk was handled. I know this workshop moved me in my understanding of both suffering and risk, and I appreciate all you did to put it together. It was very well organized and flowed smoothly.
- I see it as a very important topic for our grad students to hear about before they head to the field. Also, it is helping me process the death of a colleague who died from post-op complications the weekend after the PTM conference. It also made me more aware that I need to read and study more on the topic.
- The workshop (well, I'd really call it a seminar!) gave more perspectives and resources for evaluation suffering (real suffering – or pain resulting from needless imprudence and impulsiveness) and gauging risk for a larger than personal result.

What suggestions do you have for how we could improve this workshop?

- This is a subject I'm very interested in so I would have liked to spend more time on it.
- More time to process, more practical application.
- The workshop is great on theology and practical ideas about care. That is what the workshop is for. I wonder what could be added (if anything) to help organizations develop policies for risk.
- I don't think I can contribute to any improvement. Through the discussions and literature I took home I have much to think about and share. Thank you so much!
